In the name of God Amen The Nyne and Twentyeth day of November in the Thirteenth Yeare of the Raigne

of our soveraigne Lord Charles the Second by the grace of god of England Scotland France and Ireland king defender of the faith etc and in the yeare of our Lord god On[e] thousand five hundred Sixtie

and One I Joane Brayne of Churchill in the county of Oxford widow being weake in body

But of p[er]fect memory prayesd be god doe here make my last will and Testament in maner and forme following First I comend my soule unto god my maker and to Jesus Christ my redeemer

trusting to be saved by his merits and my body to be buried in the Churchyard of the p[a]rish of

Churchill aforesaid Also I give unto Richard Jett my grandchild the Sum[me] of Eight pounds of law full mon[e]y of England to be payd by my executor within one yeare next after my decease Also I give

unto Thomas Jett my grandchild the sum[me] of nyne pounds of like money aforesayd to be payd

by my executor within one yeare next after my decease Also I give unto Jonathan Jett my grand child the Sum[me] of Twelve pounds of like money aforesaid to be payd by my executor within

one yeare next after my decease Also I give to Margaret Jett my grandchild the Sum[me] of six pounds of like money to be payd by my executor within one yeare next after my decease Also I

give unto Elizabeth Jett my grandchild the Sum[me] of Seaven pounds of like money to be

payd by my executor within one yeare next after my decease Also I give unto Joane Jett my

grandchild the sum[me] of eight pounds of like money to be payd by my executor within one

yeare next after my decease Also I give unto Eliner Jett my grandchild the sum[me] of Tenne

pounds of like money to be payd by my executor within one yeare next after my decease

Also I give unto Richard Jett aforesayd the Round Cubord in the buttery and the salting trough

there and One bedsted Also I give unto Thomas Jett aforesayd the Table and Frame

in the hall and one tub Also I give unto Margaret Jett aforesaid my best feather bed

my biggest coffer and one little kettle Also I give unto Elizabeth Jett aforesayd my great

kettle and one coffer in my chamber Also I give unto Eliner Jett aforesayd One bedsted and

One coffer in my chamber Also I give unto Joane Jett aforesayd one bedsted over my

Chamber and one coffer over the entr[ance] Also I give unto John Jett my Son in Law one shilling

Also I give unto Elizabeth Jett the wife of John Jett aforesayd the sum[me] of thirty

shillings and my wearinge Cloathes Also I give unto John Jett the son of John

Jett aforesayd two shillings Also I give to the poore of the p[a]rish of Churchill aforesayd the Sum[me] of Three pounds As for All my other goodes and Chattles movable and unmoveable I give unto John Brayne my naturall sonne whom I doe here make my sole executor my Debts and funerall discharged and I doe ordeine Thomas Bridges the elder of Churchill and John Harvy of Churchill afores[ay]d Overseers of this my last will and Testament
