Will of Richard Hancock, of Sarsden, 1729

In the name of God: Amen I Richard Hancock Late of Idbury in the County of oxon
But now of Sarsden in the said County of Oxon being in health of Body and of good and
Perfect memory do for the Disposal of my worly Goods ^{& Estate} make and ordains this my Last will
and Testament Revoking and annulling all other will & wills before made by me either
by word or writing and this only to be Taken and Reputed as my Last will and Testament
(That is to say) I Give and Bequeath to my Daughter Grace Daulby the wife of Edward Daulby
Of Idbury aforesaid the sume of five pounds to be paid within one year after my Decease
by my Executor hereinafter named I also Give to my said Daughter Grace Daulby A Canvas
Bed which is now at my son Henry Hancoks at Sarsden aforesaid Item I Give and Bequeath to
my Daughter in Law my son Henrys wife the sume of five pounds to be paid within one year
next after my Decease Item I Give to my son Henry Hancoks Daughter Rachel Hancock to be
paid when she Com's ^{to} the age of twenty one years the sume of one pound Item I give to my
Grandchildren the Children of Edward Daulby and my Daughter Grace his now wife as followeth
(That is to say) to Jn^r Daulby the sume of one pound to be paid within one year after my
Decease if he shall be then on the age of twenty one years in not then my will is that it
Shall Lye in the hands of my Executor till he is come to that age: Item I give to
Edward Daulby the sume of one pound to be paid when he Coms to the age of twenty one
years : Item I give and Bequeath to Grace Da^ulby the sume od one pound to be paid when she
is of the age of Twenty one years Item I give to Richard Daulby the sume of one
pound to be paid when he is of the age of twenty one years Item I Give to Mary
Daulby the sume of one pound to be paid when she Com's to the age of twenty one years
all which are my Grand Children and the Children of Edward Daulby and Grace his wife
of Idbury as aforesaid : Item O Give to my son Henry Hancoke of Sarsden all that my
Cottage house and Garden with all the appurtinances Thereunto Belonging situate Lying
and being in Idbury aforesaid which I sometyme since purchased of Charles Fortescue
Esq^r and Elizabeth his wife for A Lease of ninety and nine years Determinabe on the Lives
of the persons therein mentiond for the Remainder of the term that shall be to come after
my Decease and also all the Rest and Residue of Goods and Chattels money Cloaths and Estate
in whose hands Coustody or possession they be or may be found he paying my Just Deb^{ts} Funeral

Expenses and the Legacys above mentioned who O make my sole Executor of this my Last will and Testament In Wittness whereof I have hereunto sett my hand and Seale this twenty ninth Day of Feburary in the first year of the Reighn of our Sovereign Lord George the Second by the Grace of God King of Great Brittan France and Ireland Defender of the Faith er Annoy Dom 1727
