In the Name of God Amen I William Joyner of Churchill in the County of Oxford yeoman being weake in bodie but in perfect memmorie

praise be therefore given to Almighty god doe make and ordaine this my present will and testament, in manner following that is to say

first and principally, I Commend my soule into the hands of Almighty god hopeing through the merits death and passion of Jesus Christ

my saviour to have free pardon and forgiveness of All my sins and to Inherit everlasting Life; and my body I Commit to the earth, to be

decently buried at the discretion of my Executors hereafter named; And as touching the disposition of All such temporal e(*ffects*)

As it hath pleased Almighty god to bestow upon me I give and dispose of as followeth,

First I will ; that my Debts and funeral charges shall be discharged and paide: ~~Item my wife Elizabeth~~

Item I Give unto my wife Elizabeth my house that I now dwell in and all my free Land in ^{the parish of} Churchill for terme of her Life and after

her decease the saide Land shall remaine unto my sonne William and his heirs for ever Item I give unto my wife ~~and my sonne~~

~~William~~ that barne and rickyard Caled Tappans, on the south side of the street during the term of the Lease and one

halfe yeard Land of the said Tappans yeard Land and half the Land in the feild meddow and pasture being devided into

three eaqual parts the; dwelling house of the said Tappans with All the outhouses backside and the north side of

the street with one yeard Land thereunto belonging I give unto my daughter Sarah ~~far~~ and her heirs deuring the terme of t[h]e Lease

Shee or they paying yearly and every yeare unto my wife Elizabeth the sum of fower pounds for terme of her naturall Life and then the

Saide Elizabeth shall have noe part nor Interest in the said Tappanes Lease but the before mentioned barns and Rickyard only

If my wife Elizabeth shall happen to marry Again shee shall then give to my Children the su[m]m of tenn pounds to each of them.

Item I give unto my daughter Mary my house in Chipping norton and one hundred pounds in money ~~and~~ to have and to receive the

same at the Age ^{of} one and twenty years; but if the said ^{mary} shall happene to marrie and die without Childe then the saide

house shall Remaine to my sone William and his heirs for ever; but if my wife doth or will dispose of this my ho^use in

Churchill go to my sone William shee shall then enjoy my house in Chipping norton for terme of her Life

All the rest and residue of my personal estate, goods and Chattels whatsoever I give unto my wife Elizabeth and to my sone

William; makeing them Go[o]d and Joynt executor and executrix of this my Last Will and Testament ~~doe~~ in witness

whereof I have hereunto set my hand and seale the twentieforeenth day of may in the year of our Lord 1695
