In the Name of God Amen I Thomas Spurrier of Churchill
in the County of Oxon Yeoman being weake in body But of
Perfect Mind and Memory Doe make and ordaine this
my Last Will and Testament in manner Following First
I committ my Body unto the Earth from whence it was taken
To be decently buried by my Executrix hereafter named
And My Soule I comitt into the hands of Almighty God
my Maker hopeing and assuredly trusting to be saved by
the onely Meritts of by Blessed Lord and Saviour ^{Jesus Christ} and
not for any good that is in me And For my Temporall
Estate w[hi]ch Almighty God of his Abundant Mercy hath
beene pleased to prosper me withall I dispose of as followeth
First I give unto my sonne Richard Spurrier the some
of Twenty pounds to be paid him within one yeares after
my Decease Item I give unto My Daughter Mary ---
Spurrier the some of twenty pounds to be paid unto her
w[i]thin Tenne Yeares Next after my Decease Item I give
unto my Daughter Sarah Spurrier the full summe
of Twenty pounds to be paid unto her w[i]thin Tenne
Yeares next after my Decease Item I give and bequeath
unto my Wife Anne Spurrier The Cottage w[i]thin the appurtenance
w[h]ich I bought of M^r Sessions Late of Churchill Deceased unto
my said Wife Anne Dureing her Naturall life Item I give
unto my Sonne Richard Spurrier the afforesaid Cottage w[h]ich I bought
of the said M^r Sessions Dureing all the rest & residue of my terme
yett to come & unbequeathed upon this Condi[i]on That if my sonne
George Spurrier who it was now uncertaine where he is Doe
returne ~~xxxx come~~ againe That then my said sonne Richard Spurrier shall
give & pay unto him the some of Tenne pounds in Lew thereof And

if My said Sonne Richard Spurrier shall refuse payment of
the saidsome of Tenne pounds upon the returne of my said
sonne George Spurrier then my Will is that my said Sonne George
Spurrier shall hold and inioy receive and take to his owne use
the whole estate & terme of the afforesaid Cottage after the Decease
of my said wife Anne, Item I give unto my Sonne William -----
Spurrier the Messuage w[i]th the Halfe a yard Lands belonging unto
the same w[h]ich I Lately Lived in, in Churchill afforesaid affter the
Decease of my wife, All the rest of my goods Cattells & Chattells
I give & bequeath unto my welbeloved wife Anne Spurrier whome
I make my Sole Executrix of this my Last Will & Testament In
Witnesse whereof I have heare unto sett my hand & Seale the one
& thirtieth Day of May Anno Dom[in]i 1686 Revoking all former Wills
